SUMMARY

1. Call to Order

The meeting was called to order by the Mayor. A quorum was present.

2. Public Comments

- Joeseph Grooms, a resident of the City of Brooklet addressed concerns regarding **county development near city limits**, including water access, zoning authority, and lack of coordination with city officials. The speaker emphasized the need for unified council action and equitable treatment of city residents.
- Concerns were raised regarding **public safety coverage**, particularly the need for enhanced police presence and 24/7 service.
- The speaker urged council unity and collaboration to better serve residents.

3. Blue Knights International – Public Presentation

- Stan York Director Chief representative of the **Blue Knights International (Georgia Chapter)** presented information about the organization, highlighting its charitable contributions (approximately \$14,000 donated locally in the past year).
- The group requested renewal of its lease for the Scout Hut at 100 Park Avenue South.
- Council expressed appreciation for the organization's community service.

5. Financial Report - November

- General Fund revenues: \$679,611.98 (50.57% of budget)
- Water Fund revenues: \$266,016.73 (54% of budget)
- Sanitation Fund revenues: \$88,912.96 (48% of budget); operating at a deficit due to rising disposal costs (FEMA Expenses)
- Expenditures reviewed, including purchase of a police vehicle
- Both major funds reported strong cash balances
- **Motion passed** to approve financial reports, with future discussion planned on stabilizing the sanitation fund.

6. Interim City Manager Report – Lori Phillips

- AMI water meter software nearing implementation, allowing residents to monitor water usage and detect leaks.
- City received its first **SPLOST check** for the upcoming fiscal period.
- City manager recruitment process underway with Sumter Group; materials pending council approval.

7. City Engineer Report – Wesley Parker

• Updates provided on sewer, water, and infrastructure projects.

8. Interim Police Chief Report – Nickki Garman

- Police equipment needs discussed, including:
 - Body-worn cameras
 - o Tasers (non-lethal options)
 - Radar unit replacements
- Information shared on **enterprise fleet management** options used by neighboring cities.
- Discussion initiated regarding formation of a **Police Foundation** (501(c)(3)) to support equipment and officer assistance through donations and tax credits.

9. Ordinances and Motions

- a) Ordinance#2025-031: Amending and restating the Official Zoning Map of Brooklet, Georgia.
 - Approved 5-0
- b) Ordinance #2025-032: Rezoning of property at 16862 Highway 80 East from R-1 to C-2
 - Approved (second and final reading) 4 ayes and 1 recused
- c) Lease Agreement: 2025 lease renewal with Blue Knights for Scout Hut
 - Approved 5-0

9. Brooklet Cemetery Improvements Proposal – Ann Clifton

- Presentation given outlining historical significance of the city cemetery.
- Proposed improvements included:
 - o Replacement of white vinyl fencing with historically appropriate metal fencing
 - o Restoration and maintenance of cemetery entrance
 - Water access restoration
 - o Long-term beautification planning and potential irrigation
- Plans discussed to form a 501(c)(3) nonprofit for cemetery preservation.
- Council expressed interest in further review and preservation options.
 - Approved 5-0

10. Additional Discussion

- Council discussed reviewing and updating **parking ordinances**, particularly regarding nonconforming and historic properties.
- Planning Commission involvement was suggested for ordinance review.
 - Approved 5-0
