2. Recognition of Guest:

2.1.Don Roberson - Bipolar Ionization Device

Bipolar ionization, or needlepoint ionization, is the electrical charging of air as it passes through an ionization field. The system energizes the air to form bipolar (positive and negative) air ions. The HVAC system distributes the energized ions into all of the spaces served by the duct system in an in-duct installation. Ions are attracted to pathogens in the air, such as viruses, and bonds to them, this interrupts their bond to a hydrogen element and prevents the pathogen from replicating so it becomes inactive. The bipolar ionization units University of Richmond installed produce less than 0.05 ppm of ozone; OSHA limits on ozone exposure are 0.05 ppm for an 8-hour day performing rigorous physical work and 0.1 ppm for an 8-hour day performing light work. Therefore, this decades-old technology can be used in occupied spaces.

Benefits of using in bipolar ionization in HVAC equipment include, but are not limited to:

- · Reduced dust and mold particles.
- Reduced odors. Bipolar ions break down odors at their source and eliminate them — no masking or diluting!
- Reduced VOCs (Volatile Organic Compounds).
- Reduced bacteria and viruses. Bipolar ions negatively affect the DNA of bacteria and viruses which protects your space's inhabitants from illness and disease.
